KERJA PENGUKURAN ARUS DI PERAIRAN PELABUHAN W.P. LABUAN /
CURRENT MEASUREMENT @ LABUAN PORT LIMIT

Masyarakat perkapalan adalah dimaklumkan bahawa kerja-kerja pengukuran arus di sekitar perairan boya Harbour Shoal (*kedudukan adalah sepertimana yang dilampirkan*) dijangka akan bermula dari 03hb. Ogos 2005 (Rabu) hingga 06hb. Ogos 2005 (Sabtu).

Kerja-kerja pengukuran akan dijalankan 24 jam berterusan.

Kerja-kerja tersebut melibatkan pemasangan peralatan pengukuran di dasar laut. Kedudukan peralatan pengukuran tersebut akan ditandakan dengan boya penanda berwarna merah dan berlampu putih (*White Flashing Light Beacon*) pada waktu malam.

Sehubungan itu, semua kapal, feri dan bot yang belayar di dalam Kawasan Pelabuhan W.P. Labuan adalah **diwajibkan** mengurangkan kelajuan dan menjauhi daripada bot yang menjalankan kerja-kerja pengukuran dan boya penanda yang dipasang.

Shipping community is hereby notified that Current Measurement work in the vicinity of Harbour Shoal Buoy (*location/area of work as per attachment*) is expected to be carried out from 3rd August 2005 (Wednesday) to 6th August 2005 (Saturday).

Current Measurement will be carried out 24 hours continuously.

The work includes deployment of ADCP equipment to the sea bottom and the location of the equipment will be marked with red colour marker buoy with light flashing white at night.

All vessels, passenger ferries, passenger boats and any other type of water crafts being used as means of transportation on water are required to reduce speed and keep well clear from the work boat and marker buoy when plying in the vicinity.
